

The both parties agree as follows:

1. First party declares that Dr. Qadri's Mental Health Center, Multi-specialty Clinic, Padegaon, Chhatrapati Sambhajanagar, Nasik Road, Padegaon is a 120 bedded Mental Health Center.
2. First party agrees to provide clinical experience for Diploma, Undergraduate and Post Graduate nursing students as in syllabus.
3. It is compulsory for the students to come for the posting to the hospital for clinical experience.
4. Topics of the lectures, date and duration of posting, names and number of students at posting, name of the supervisor accompanying the students is to be informed to the hospital one month before the posting schedule commences.
5. The students are expected to be punctual, regular, attentive and willing to work in psychiatry.
6. Students should be accompanied and supervised by the college supervisors.
7. Students are not allowed to drink or smoke in hospital premises.
8. Students are expected to follow the instructions given at the hospital by seniors. Any misbehavior with the patient and/or staff shall not be forgiven.
9. Charges for affiliation Rs. 25,000/- are to be paid prior to obtaining written permission of affiliation.
10. Affiliation will be given to the institution only for three consecutive years. At the end of this period, affiliation needs to be renewed.
11. Fees per student per posting will be Rs. 1500/- for students. It has to be paid at the time of commencement of posting.
12. The officials representing first and second party are signing this MOU to achieve beneficial objectives of Nursing courses.
